

CONSTRUCTION WORK IN ANGAGA ISLAND RESORT & SPA



As part of Angaga Island's commitment to enhance the property and its services the resort has planned construction work from 1st May 2023 until end of October 2023. This construction work involves the demolishing of existing 20 units of Water Bungalows and Sundown Bar and build new spacious 24 units of Premium Water Bungalows with a new Sundown Bar to improve our guest stay experience and comfort.

Please refer to the above work site plan where we have marked the working area with red lines and note that this area will be covered with a fence. We will ensure that the construction work is carried out as quietly and unobtrusively as possible to avoid any inconvenience to our mutual guests.

Once the construction is completed, Angaga Island will have a total of 94 rooms with 3 categories of rooms as follows:

50 Superior Beach Bungalow (existing category) 45sqm

20 Superior Water Bungalow (existing category) 65sqm

24 Premium Water Bungalow (new category) 78sqm

Furthermore, for all EXISTING bookings in Angaga Island we will offer the following options:

Option A: They can choose to change the island to our sister resorts (Dreamland/Safari Island/ Thulhagiri Island) without any additional charges, subject to room availability.

If they choose to stay on Angaga Island, they can choose either Option B or Option C:

Option B: 20% discount on room rate and meal plan (combinable with contracted EBO offer)

Option C: Complimentary meal upgrade from Half Board to All Inclusive (combinable with contracted EBO offer)
